#### SDR ON THE CHEAP



The title of the June Meeting's talk obviously resonated well as there was an excellent number of members who attended and were treated to a well researched and most interesting and thought provoking evening.


The talk commenced with the introduction of a typical cheap

(approx £10) device -RTL SDR (E4000) which offered a 3.2 MHz bandwidth and a tuning range of approx 50 to 2200 MHz (gap between 1100 and 1250 MHz) together with its internal block diagram :-




Once plugged into a computer usb port and used with appropriate software - examples of which quoted were Zadig for drivers, SDR Sharp, and SDR Radio - (all for Windows), then the number of uses to which this device could be put were mind boggling!.

Examples demonstrated by Mike included acting as a 6m/4m/2m/70cm RX,



#### airband scanner and tracker,



weather satellite RX, and with an HF up convertor as an HF RX. Even budget Radio Astronomy was included! Finally, this cheap SDR was compared with the more expensive FunCube Dongle Pro+





#### APPLEDORE & DISTRICT AMATEUR RADIO CLUB CONSTITUTION

#### (July 2014)

#### 1. <u>NAME</u>

The society shall be known as the Appledore and District Amateur Radio Club.

#### 2. <u>AIMS</u>

The aim of the Club shall be to further the interests of its members in all aspects of Amateur Radio and associated activities.

#### 3. <u>MEMBERSHIP</u>

Membership shall be open, subject to the discretion of the Committee, to all persons interested in the aims of the Club.

#### (a) Full Members

Full Members must be 16 years of age or over, OR must hold the permission of any competent authority to install and operate an amateur radio station.

#### (b) Student Members

Student Members must be in full time education, and under 25 years of age.

#### (c) Honorary Members

Honorary Membership may be granted to any person, who, in the opinion of the Committee, has rendered outstanding service to the Club, either directly or indirectly. Such membership shall carry the rights of full membership but shall be free of subscription.

#### (d) Guests

Members may invite guests to meetings. No visitor may attend more than three meetings in each year.

All members shall abide by the Constitution of the Club. The Committee shall have the power to expel any member whose conduct, in the opinion of at least three-quarters of the full Committee, or a General Meeting, renders that person unfit to be a member of the Club. No member shall be expelled without first being given an opportunity to appear before the Committee. The Club is committed to the protection of minors and vulnerable adults and fully adopts the recommendation from the RSGB entitled "Safeguarding Children and Vulnerable Adults" which is appended to this Constitution.

#### 4. SUBSCRIPTIONS

- (a) The Annual Subscriptions for membership shall be set by the Committee, but ratified at a General Meeting.
- (b) All subscriptions shall be due and payable at the beginning of the financial year. Members more than one month in arrears shall have no voting rights.
- (c) The financial year shall run from 16th February to 15th February.
- (d) A member shall be considered to have resigned from the Club, if by the following May 31st the subscription remains unpaid.
- (e) The Committee shall have the power to waive or reduce the subscription in special circumstances for a period not exceeding one year at a time.

#### 5. FINANCE

All money received by the Club shall be promptly deposited in the Club's Bank account. Withdrawals need the signature of the Club's Treasurer and one other nominated officer of the Club.

#### 6. MEMBERSHIP OF THE COMMITTEE

The Club's affairs shall be administered by a Committee elected at the Annual General Meeting. The Committee, in whom the Club's property shall be vested, shall consist of :-

- (a) A Chairman, who will preside at all meetings at which he is present.
- (b) A Vice-Chairman, who will act as Chairman in the absence of the Chairman.
- (c) A Secretary, who will be responsible for:-
  - (i) Keeping the Minutes of all meetings of the Club.
  - (ii) Ensuring that all correspondence is correctly handled.
  - (iii) Maintaining a master roll of Members and Honorary Members.
  - (iv) Maintaining a register of Club equipment.
- (d) A Treasurer, who will be responsible for:-
  - (i) Keeping the Club's accounts.
  - (ii) Advising the Committee on all financial matters.
  - (iii) Preparing the accounts for audit, and presenting them at the AGM
- (e) Three Ordinary Committee Members.
- (f) Not more than two co opted members who have full voting rights
- (g) The Committee shall have the right to appoint Members to various Club Roles as and when the need arises. Such appointments shall automatically include eligibility to be co opted in a non voting capacity onto the Committee.

#### 7. <u>COMMITTEE STANDING ORDERS</u>

- (a) The Quorum for the Committee shall be four. In the absence of a Quorum, business may be dealt with, but any decisions taken only become valid after ratification at the next meeting at which a Quorum exists.
- (b) Committee Meetings may be called by the Chairman, the Secretary, or any three Full Members of the Committee.
- (c) The Chairman may vote; in the event of a tie he has a second casting vote.

#### 8. ANNUAL GENERAL MEETING

- (a) The Annual General Meeting shall normally be held on the third Monday of March each year. At least 21 days notice shall be given to each member in writing.
- (b) The Quorum for the meeting shall be twelve.
- (c) The Agenda of the meeting shall be:-
  - (i) Apologies for absence.
  - (ii) Minutes of the previous AGM.
  - (iii) Chairman's Report.
  - (iv) Secretary's Report.
  - (v) Treasurer's Report.
  - (vi) Election of the new Committee.
  - (vii) Election of Auditors.
  - (viii) Other Business.
- (d) Items (i) to (v) shall be chaired by the out-going Chairman; item (vi) by an acting Chairman who is not standing for election to office; the remaining business by the newly elected Chairman.
- (e) Nominations for Committee Members will be valid only if confirmed by the nominee, or previously in writing.

### 9. EXTRAORDINARY GENERAL MEETING

- (a) Extraordinary General Meetings may be called by the Committee, or not less than 8 members of the club; the date of this next meeting being the earliest convenient as decided by the Committee. At least 28 days notice in writing must be given to the Secretary, who in turn, shall give members at least 14 days notice in writing of the Agenda.
- (b) The Quorum for the EGM shall be half the Club membership.

#### 10. AMENDMENTS TO THE CONSTITUTION

The Constitution may be amended only at an EGM called for that purpose.

#### 11. WINDING UP OF THE CLUB

- (a) The decision to wind up the Club may be taken only at an EGM.
- (b) The funds of the Club shall, after the sale of all assets and the payment of all outstanding debts, be disposed of as directed by Members at the final EGM.

# <u>Appendix</u>

# Safeguarding Children and Vulnerable Adults

# 1. <u>Introduction</u>

- 1.1 The whole area of safeguarding children and vulnerable adults is currently subject to much change and we need to keep abreast of those changes. All clubs are reminded of their responsibility to take all reasonable steps to safeguard the welfare of children and vulnerable adults when they are engaged in club activity and/or on club premises.
- 1.2 A child is someone under the age of 18.
- 1.3 A vulnerable adult is someone aged 18 or over:
  - who is, or may be, in need of community services due to age, illness or a mental or physical disability and
  - who is, or may be, unable to take care of himself/herself, or unable to protect himself/herself against significant harm or exploitation (Department of Health 2002).

Where this note refers to children, similar considerations apply throughout to vulnerable adults.

- 1.4 A scheme was set up following the enactment of the Safeguarding Vulnerable Groups Act 2006 to vet individuals who had access to children or vulnerable adults through their work or voluntary activities. As far as the RSGB was concerned, compliance with the Act entailed carrying out CRB checks on what where then known as Registered Instructors .
- 1.5 In 2010 the government announced that the scheme would be scaled back in a "common sense and proportionate" way and, as a result, new legislation (The Protection of Freedom Act 2012) will be enacted this month (September 2012).
- 1.6 Around the same time, the RSGB and the RCF recognised that there was no requirement for Instructors to be registered with the RSGB; in reality, anyone could deliver training, including selftraining by exam candidates. The policy was therefore changed so that only those individuals that carry out Practical Assessments need to be registered with the RSGB and were then subject to CRB clearance. These are official roles carried out on behalf of the RSGB/RCF, with the responsibility of saying that candidates are competent in specific activities prior to being allowed to sit the appropriate examination. In reality, most Assessors are also Instructors, but that is not a requirement.
- 1.7 This note advises of changes to RSGB policy regarding CRB checks, provides advice to clubs and independent training providers on their position and recommends good practice.
- 1.8 Further legislative changes are planned later in the year and further guidance will be issued if required.

# 2.0 <u>Discussion</u>

2.1 The Society has the responsibility for ensuring compliance with the regulations as far as its staff and volunteers are concerned. In practice this affects Registered Assessors (i.e. those who carry out practical assessments prior to Foundation and Intermediate examinations).

- 2.2 Clubs and independent training providers have the responsibility for ensuring compliance for volunteers who teach students or supervise examinations, within the context of their overall duty to protect children and vulnerable adults. This means trainers and examination Invigilators.
- 2.3 The CRB Checks Guidance for Volunteering published in 2008 states that the decision as to whether to make a CRB check is a matter for the employer. Our legal advice is that "Employer" in this context means the RSGB for Registered Assessors, and clubs and independent providers for trainers and examination invigilators. It goes on to state that the decision should be part of an overall risk management process. The decision should, it states, be made "carefully" and "because there is a strong and demonstrable reason for doing so and not just in case".
- 2.4 The "test" for assessing whether a person is recommended and eligible for a CRB check is if
  - a) they engage in a "regulated activity" (in this case, any form of teaching, training or instruction of children and/or vulnerable adults) **AND**
  - b) they carry out this activity **EITHER** frequently (once a week or more) **OR** on more than 3 days in any 30 day period.
- 2.5 After careful consideration of the advice it is clear that
  - Some trainers may fall within the definition in 2.4, depending on who they teach and how their teaching time is structured.
  - The role and scope of registered assessors do not fall within the definition in 2.4 and RSGBsponsored CRB checks will cease. RSGB HQ will continue to take up references before registering assessors. Some registered assessors are also trainers, however, and may qualify for a CRB check depending on 2.4 above.
  - The role and scope of examination invigilators do not fall within the definition of a regulated activity. Some examination invigilators are also trainers, however, and may qualify for a CRB check depending on 2.4 above.
- 2.6 Notwithstanding the above, it may be that some trainers already have CRB clearance due to their activities outside of the club.

# 3.0 <u>Recommendations</u>

- 3.1 All RSGB Affiliated Clubs should formally adopt and implement the RSGB Child Protection Guidelines whether they teach students or not, and this should be made widely available. The RSGB Guidelines are available on the website using the following link <a href="http://www.rsgb.org/tutors/general/pdf/childprotection.pdf">http://www.rsgb.org/tutors/general/pdf/childprotection.pdf</a>
- 3.2 All independent clubs and independent training providers should develop a Child Protection Policy whether they teach students or not, and this should be made widely available. Guidance is available on the RSGB website using the following link <a href="http://www.rsgb.org/tutors/general/pdf/childprotection.pdf">http://www.rsgb.org/tutors/general/pdf/childprotection.pdf</a>
- 3.3 All clubs should review their teaching schedules. If a trainer's teaching commitment falls within the definitions described in 2.4 above then a risk assessment must be undertaken by the club or independent provider to determine whether a CRB check is warranted. There should be consideration of how well the risk is mitigated by the attendance of parents or other responsible adults.

3.4 If the risk assessment causes the club or independent provider to decide that a CRB check is warranted then it is their responsibility to initiate the check. The General Manager is available for advice in such cases. Please send a copy of your risk assessment to <u>gm.dept@rsgb.org.uk</u>. in the first instance.
Please note that if the trainer is an RSGB member. RSGB HO will organise and fund an agreed check

Please note that if the trainer is an RSGB member, RSGB HQ will organise and fund an agreed check on their behalf. Non-members will need to make their own arrangements.

#### 4.0 <u>Conclusion</u>

4.1 The RSGB is committed to protecting children and vulnerable people from abuse, and supporting affiliated clubs in their endeavours in this respect, as a result of their amateur radio activity. The guidance above, and the RSGB Guidelines referred to, provide a proportionate framework within which we can work.

# ADARC CLUB GUIDELINES

# <u>General</u>

- These Club rules are authorised by the Committee and will be maintained by the Club Secretary.
- Any comments or amendments should by forwarded to the Sec. They will be reviewed annually.
- Nothing in these rules is intended to contradict the Club Constitution. Any inadvertent conflict should be brought to the attention of the Sec.

# **Objective**

The objective of ADARC is to promote the educational hobby of Amateur Radio in the North Devon area as an affiliated club of the Radio Society of Great Britain (RSGB).

# Club Officials

President Chairman Vice Chairman Treasurer Secretary 3 Elected Committee membership Maximum 2 co-opted members with full voting rights The Committee shall have the right to appoint Members to various Club Roles as and when the need arises. Such appointments shall automatically include eligibility to be co opted in a non voting capacity onto the Committee.

# Safety

- The safety of Club members and members of the Public should always be the paramount consideration in the organisation of any Club events.

- In particular, Health & Safety regulations and the protection of minors and vulnerable adults must be fully considered in all Club activities.

- Members are responsible for their and the public's safety when operating their stations and equipment when used for Club activities.

# <u>Membership</u>

- Club membership is open to all, whether licensed and non-licensed, who have an interest in Amateur Radio.

- The annual subscription (currently  $\pm 13$ ) runs from March each year and members are requested to pay by end May. Late subscriptions will normally be accepted at the discretion of the Treasurer!

- All members should complete a Club Membership Form which will be used by the Secretary to maintain a register of members.

- Members under 18 should have parents or guardians permission to join the Club.
- Members under 16 should be accompanied by an adult approved in writing by their parent or guardian. <u>Meetings</u>
- A monthly meeting will be held in the Appledore area. Visitors are welcome, but regular attendance will

normally be expected to lead to a request for Club membership.

- It is intended that one of the meetings each year will be on a non-radio theme to encourage family and friends to attend.

# Monthly magazine (5&9)

- A monthly magazine will be e-mailed to members. Those who wish a hard copy can make arrangements with the Club Secretary for a postal copy, but must provide stamps or preferably an SAE.

# Club Callsigns

- The Club holds the following callsigns :- GX2FKO and G2FKO

- The Club licence holder is M0JKL, who is responsible for the correct use of the Club call and approving the arrangements for use of this

# **Operating Standards**

- Members should always operate within the terms of their OFCOM Licence. Foundation and Intermediate licence holders may operate the Club station at full power under the supervision of an approved full licensee.

- All members are encouraged to promote high operating standards and adopt the approved operating procedures as indicated on the accompanying RSGB 'Good Amateur Radio Operating Practices' document.

- This is particularly important when operating or joining Club nets. These may be listened to by a wide variety of SWLs, including Children, and visitors to the area. The regular nets act as the Clubs' 'Shop Window'

- Remember that all electronic communication is 'open'. Never say anything on air that you would not be prepared to see reported on the front page of the 'Daily X....' !!

# <u>Club Equipment</u>

- The Club has several transceivers and ancillary equipment. The Club Secretary acts as the custodian. Equipment may be purchased or disposed of as agreed by the Committee. It may be necessary to raise money, on occasion, should members agree that significant new equipment purchase is desirable.

- The Club equipment is available for use at 'events' and may be loaned to licensed club members for specific purposes.

# Club Affiliation

- The Club will maintain an affiliation with the RSGB.

- The club also has affiliation with FISTS (No 15,870). Operating Events/ Contests

- The Club will plan to run a station at various local public events during the year. This both helps to increase the profile of Amateur Radio with the public, and provides members with an opportunity to set up and operate a 'temporary' station. All Club members are encouraged to visit these events. Volunteers who assist in running and operating the station are particularly welcome, and it usually provides an 'educational'

experience in one way or another.

- Although the Club is not historically a 'Contest Club', there are many smaller activity and special events that provide an ideal opportunity to experience and participate in station operation, with a good number of stations on the air. A Club aim is to encourage and facilitate members or groups who would like to participate in any of these (for example the RSGB club cumulatives).

# Good Amateur Radio Operating Practices

#### Showing consideration for

- Remember that radio contacts are private – the amateur radio community is a public place
- Use language that is clear and will not offend
- · Leave music to the broadcast stations
- Keep a copy of the band plans to hand and follow them
- Use amateur codes and abbreviations on amateur bands when they are appropriate (e.g. Two Echo Zero, QSY, 73, 5&9) and avoid codes or jargon from other radio users (e.g. CB, PMR, military, marine)

- Keep overs short as you would conversation – new friends might want to join in or conditions might change such that your signals fade away
- If you find another station on 'your' frequency politely ask them to move, or move your QSO to a clear frequency – propagation may have changed and they may have been there all the time
- Find a clear frequency to tune up on and keep a note of your ATU settings for quick retuning next time you use the band
- Reduce power to minimum whilst tuning it's safer for your radio and less interference to others

#### Calling other stations

- Listen carefully to the CQ call – is it a general call to all or a specific call to one continent or country?
- Only call if the general or for your area (e.g. 'CQ UK' or 'CQ Europe') or your callsign group (e.g. 'calls with zero only') your turn will come - be patient



Always give your callsign in full remember to send the other station's call first (e.g. 'Delta Six Eight Charlie from Golf Zero Alpha Bravo Charlie)

- Answer CQ calls once then listen; only call again if no other station has been identified – be patient
- If the station you are calling is not working anyone near you wait a while and try again later – be patient
- Try calling CQ on bands that sound dead – others may be waiting for a call
- Remember, there is no need for 'CQ' on a repeater just 'M6XYZ listening through GB3UB' is enough

#### Helping

- Keep the hobby growing and help newcomers to get started
- Offer friendly advice to help others improve their skills
- If you can hear someone calling CQ and no one is answering, give them a call, even if it is just to let them know their signals are getting out

#### **Learning**

- Familiarise yourself with your own equipment (e.g. Know how to work 'split')
- Read through the whole of your Licence – the training doesn't cover all of it but you must comply with the parts that apply to you

Read up on topics of interest (the RSGB operating manual is a mine of information)

Try new ways of operating (e.g. back-

- Always give accurate signal reports you need 3 repeats, they cannot be 5&9
- Inspire others to be good operators by being one yourself
- If someone needs help (e.g. with putting up an antenna) lend a hand – you may need help next time



# Being

- Use the bands without abusing privileges that your Licence gives you
- Join in club activities (local, national or both) – they provide an excellent opportunity to help others and to
- Experiment with different bands, modes learn by doing
- If you don't know something, try to find the answer, search the web, read some books or ask for help
- Set yourself some goals (e.g. To upgrade your licence by the end of the year,
